**By indicating your acceptance, you understand, agree, warrant and covenant as follows:**

The Participant desires to participate in any Vision Lacrosse Academy LLC event or Motor City Knights Lacrosse event. (Vision Lacrosse Academy LLC is to be referred to herein as Vision Lacrosse Academy or VLA and Motor City Knights Lacrosse is owned and operated by Vision Lacrosse Academy LLC). Events to be deemed as any athletic event such as but not limited to games, practices, scrimmages, tournaments, clinics and camps.

This form is an important legal document. It is critical that you read and understand it completely in its entirety. After you have done so, please print your name legibly and sign below. In this document, the term "Participant" includes both the on-the-field Participant and the parent or legal guardian, if Participant is less than 18 years of age. Participation in the sport of lacrosse may result in injury or death to Participants. The Participant desires and agrees to participate in the sport of lacrosse despite these risks.

Participation in any VLA or Motor City Knights Lacrosse event is expressly conditioned upon the following agreement by the Participant:

1. Participant assumes all risks of injury or death sustained while participating in the sport of lacrosse or while on or about the premises, and waives all liability against VLA LLC, their officers, employees, and all affiliated entities including Motor City Knights Lacrosse personnel and governing bodies.
2. Participant releases, discharges, indemnifies and holds harmless VLA/Motor City Knights Lacrosse, their officers, employees, and all affiliated entities, from any and all claims, demands or causes of action that are in any way connected with participation in the sport of lacrosse or use of the premises, facilities or equipment, and including any negligence on the part of VLA/Motor City Knights Lacrosse, their officers, employees, agents, officials and all affiliated entities.
3. VLA/Motor City Knights Lacrosse is not responsible for Participant's fitness, abilities or equipment.
4. Participant represents and acknowledges that Participant has adequate insurance and agrees to assume full responsibility for any and all costs or expenses occasioned by an injury or medical need arising out of participation in the sport of lacrosse or use of the premises, facilities or equipment.
5. Participant acknowledges that during the course of their activities VLA/Motor City Knights Lacrosse may take the Participants photograph or video. Each participant hereby grants VLA/Motor City Knights Lacrosse permission to use any such photograph or video for use in materials promoting VLA/Motor City Knights Lacrosse. Such use may include publication in programs, general marketing and advertising, posters, flyers, television, website and any other vehicles that may be distributed or shown to or otherwise seen by large numbers of individuals and potential patrons of VLA/Motor City Knights Lacrosse. Participant waives all rights to any financial remuneration of any kind.
6. I understand that the directors reserve the right to remove any participant whose behavior is deemed disruptive to the best interest of the other team participants with no refund of fees paid.
7. Any use of the VLA/Motor City Knights name or logos can only be used with written consent.
8. I understand that VLA/Motor City Knights Lacrosse is a faith based organization and is founded upon Judeo-Christian ethics. VLA reserves the right to express these Constitutional fundamental values in addition to the teaching of the sport of lacrosse.

VLA/Motor City Knights reserves the right to remove a player from the team if they violate the team rules in regards to no using foul language, use of tobacco, drugs, alcohol, excessive mean behavior that is detrimental to the core beliefs of VLA/Motor City Knights. There will not be a refund of any registration fees if your player is removed from the team for violating our policies.
10. There is a 24 hour grace period after each event for parents to contact the coaches. Parents can contact the coach(es) after 24 hours via email or telephone. If parents still think the issue was never resolved or not dealt with in a proper manner then the director of Vision Lacrosse Academy should be notified.
